Waiver of Dues and Obligations Contract

**Special Cases and Process for Dues or Parent Volunteer
Waiver of Obligation from the BOD**

If an existing rower's family or rower is in a position in which they are unable to meet the financial requirements or other obligations of the club, the club's position is to make every effort to allow the rower the privilege of rowing in the club. The family or Rower should request a Waiver of Dues and Obligations Application from a Board Member and submit the request in writing for review by the Board. The BOD may conditionally approve a waiver and provide stipulations which must be met by the family and rower to maintain the waiver. The Board may cancel the waiver at any time with 30 days notice of the cancellation. The rower and member family is expected to remain in good standing throughout the scholarship year. Each year, a new application is required.

If a rower's family is on scholarship or other financial relief, and there is a family situation which precludes their parents from volunteering or participating in fundraising, it is the Board's position to still allow the rower to participate given the circumstances warrant such relief. The rower should submit his/her situation privately to the Coach or to a Board member. The Board will meet in a closed session and the decision will be provided to the rower. The rower is expected to remain in good standing throughout his/her time with GBCC. The board will document the decision and will protect the privacy of the individuals involved.
